Howard Government shows strong Small Business in FLINDERS through Initiatives in 2006 & 2007

I am delighted to inform Small Businesses in the Electorate of Flinders of some of the new initiatives that have been introduced by the Howard Government to reduce red tape and to make running a business easier:

✓ Assisting Drought Affected Businesses

It's not just farmers that are doing it tough during the prolonged drought – but also the businesses that rely on those farmers for trade. That's why the Howard Government has extended the Exceptional Circumstances (EC) drought relief to the thousands of small businesses in EC declared areas that derive 70% or more of their total income directly from agriculture. The Small Business Drought Assistance will provide income support and interest rates subsidies up until at least March 2008. \$48,000 Community Water Grant for Dairy Farm Water Saving Project

Greg recently visited Candowie Lance Creek and spoke with local Farmers about the progress of their \$48,000 Federal Government Community Water Grant.

Local Farmers supporting this project will save over 186,000 litres of water each year by recycling effluent from six dairy farms around Candowie Lake.

✓ Tax Concessions

The Howard Government has moved to ensure small businesses with an annual turnover of less than \$2 million will be able to access a greater range of tax concessions. This will simplify small business eligibility for concessions in areas like GST, Capital Gains Tax and PAYG. More information is available at: www.treasurer.gov.au.

✓ Depreciation: providing incentives for Business to invest

The Howard Government's Budget decision to increase the diminishing value rate for depreciation from 150% to 200% for eligible assets, means that businesses can now write off the cost of new plant and equipment more rapidly; making it easier for businesses to invest.

✓ Fringe Benefits

From 1 April 2007, the minor fringe benefits exemption threshold will increase from \$100 to \$300 and the fringe benefits reporting exclusion threshold will increase from \$1000 to \$2000. The Government will also be excluding pooled motor vehicles (that is, vehicles used by more than one employee) from FBT reporting.

✓ Helping Small Business with OHS

✓ Preventing Crime on Small Business

Too often small businesses are affected by crimes like theft, vandalism, fraud and e-crime. ✓ WorkChoices

The Howard Government's WorkChoices system has exempted small businesses from Labor's unfair dismissal laws and given businesses the flexibility and choice they need to get on with business. ✓ Super Benefits for Small Business

Self employed Australians will be able to contribute up to \$1 million over their lifetime to their superannuation, from the sale of small business assets which have been held for 15 years. From 1 July 2007, self employed people will be able to claim the same deductions as employers making contributions on behalf of their employees and will get access to the Government's co-contribution scheme which delivers up to \$1,500 into the super accounts of low and middle income earners as an incentive to save for their retirement.
